We treat Lorentz gauge condition in quantization of electromagnetic potential.

### 1. INTRODUCTION

The article treats quantization of electromagnetic field that is defined in Rindler space-time.

Rindler coordinate transformations are

$$ct = \left( \frac{c^2}{a_0} + \xi^1 \right) \sinh \left( \frac{a_0}{c} \xi^0 \right), \quad x = \left( \frac{c^2}{a_0} + \xi^1 \right) \cosh \left( \frac{a_0 \xi^0}{c} \right) - \frac{c^2}{a_0}$$

$$y = \xi^2, z = \xi^3 \quad (1)$$

At first, in inertial frame, the quantization of electromagnetic potential is [2]

$$A_\mu(x) = \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \varepsilon_\mu^{(\lambda)}(k) [\alpha^{(\lambda)}(k) \exp(-k^\rho \cdot \vec{k} + i\omega t) + \alpha^{(\lambda)+}(k) \exp(k^\rho \cdot \vec{k} - i\omega t)]$$

In this time,  $|k| = \frac{\omega}{c}$ ,  $\vec{k} = (k_1, k_2, k_3)$ ,  $\varepsilon^{(\lambda)} \cdot \varepsilon^{(\lambda')} = g^{\lambda\lambda'}$

$$\vec{k} \cdot \vec{\lambda} - i\omega t = ik_x + ik_y + ik_z - i\omega t$$

$$= i\vec{k} \left[ \left( \frac{c^2}{a_0} + \xi^1 \right) \cosh \left( \frac{a_0 \xi^0}{c} \right) - \frac{c^2}{a_0} \right] + ik_x \xi^2 + ik_y \xi^3 - i\frac{\omega}{c} \left[ \left( \frac{c^2}{a_0} + \xi^1 \right) \sinh \left( \frac{a_0 \xi^0}{c} \right) \right] \quad (2)$$

According to [1], the quantization of Electromagnetic potential is in Rindler space-time,

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \varepsilon_{\xi^0}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{\lambda} + i\omega t) + a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{\lambda} - i\omega t)]$$

$$\varepsilon_{\xi^0}^{(\lambda)}(k) = \frac{1}{(1 + \frac{a_0}{c^2} \xi^1)} [\varepsilon_0^{(\lambda)}(k) \cosh(\frac{a_0 \xi^0}{c}) - \varepsilon_1^{(\lambda)}(k) \sinh(\frac{a_0 \xi^0}{c})] \quad (3)$$

Hence, the quantization of Electromagnetic potential in X-axis

$$A_{\xi^1} = -\phi \sinh(\frac{a_0 \xi^0}{c}) + A_x \cosh(\frac{a_0 \xi^0}{c})$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \varepsilon_{\xi^1}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{\lambda} + i\omega t) + a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{\lambda} - i\omega t)]$$

$$\varepsilon_{\xi^1}^{(\lambda)}(k) = -\varepsilon_0^{(\lambda)}(k) \sinh(\frac{a_0 \xi^0}{c}) + \varepsilon_1^{(\lambda)}(k) \cosh(\frac{a_0 \xi^0}{c}) \quad (4)$$

So, the quantization of Electromagnetic potential in Y-axis

$$A_{\xi^2} = A_y$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \varepsilon_2^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{\lambda} + i\omega t) + a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{\lambda} - i\omega t)]$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \varepsilon_{\xi^2}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{\lambda} + i\omega t) + a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{\lambda} - i\omega t)]$$

$$\varepsilon_{\xi^2}^{(\lambda)}(k) = \varepsilon_2^{(\lambda)}(k) \quad (5)$$

Therefore, the quantization of Electromagnetic potential in Z-axis

$$A_{\xi^3} = A_z$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \varepsilon_3^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{\lambda} + i\omega t) + a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{\lambda} - i\omega t)]$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \varepsilon_{\xi^3}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{\lambda} + i\omega t) + a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{\lambda} - i\omega t)]$$

$$\varepsilon_{\xi^3}^{(\lambda)}(k) = \varepsilon_3^{(\lambda)}(k) \quad (6)$$

Lorentz gauge condition is in inertial frame and accelerated frame in quantization of electromagnetic potential[1],

$$0 = \frac{1}{c} \frac{\partial \phi}{\partial t} + \vec{\nabla} \cdot \vec{A} = \frac{1}{c} \frac{\partial \phi_{\xi}}{\partial \xi^0} + \vec{\nabla}_{\xi} \cdot \vec{A}_{\xi} + \frac{1}{(1 + \frac{a_0 \xi^1}{c^2})} \frac{a_0}{c^2} A_{\xi^1}$$

$$\varepsilon_0^{(\lambda)}(k) i \frac{\omega}{c} - i k_1 \varepsilon_1^{(\lambda)}(k) - i k_2 \varepsilon_2^{(\lambda)}(k) - i k_3 \varepsilon_3^{(\lambda)}(k) = 0 \quad (7)$$

## 2. QUANTIZATION OF ELECTROMAGNETIC FIELD IN INERTIAL FRAME

Second, in inertial frame, the quantization of electromagnetic field is

 &= \int \frac{d^3k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_1^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{x} - i\omega t)] \\
 \bar{\epsilon}_1^{(\lambda)}(k) &= ik\epsilon_0^{(\lambda)}(k) - \frac{i}{c}\omega\epsilon_1^{(\lambda)}(k)
 \end{aligned} \tag{8}$$

Hence, the quantization of magnetic field is in X-axis

 B_x &= \frac{\partial A_z}{\partial y} - \frac{\partial A_y}{\partial z} \\
 &= \int \frac{d^3k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_1^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{x} - i\omega t)] \\
 \bar{\epsilon}_1^{(\lambda)}(k) &= -ik\epsilon_3^{(\lambda)}(k) + ik\epsilon_2^{(\lambda)}(k)
 \end{aligned} \tag{9}$$

So, the quantization of electric field is in Y-axis

 \bar{\epsilon}_2^{(\lambda)}(k) &= ik\epsilon_0^{(\lambda)}(k) - \frac{i}{c}\omega\epsilon_2^{(\lambda)}(k)

Therefore, the quantization of magnetic field is in Y-axis

 B_y &= \frac{\partial A_x}{\partial z} - \frac{\partial A_z}{\partial x} \\
 &= \int \frac{d^3k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_2^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{x} - i\omega t)] \\
 \bar{\epsilon}_2^{(\lambda)}(k) &= -ik\epsilon_1^{(\lambda)}(k) + ik\epsilon_3^{(\lambda)}(k)
 \end{aligned} \tag{11}$$

Hence, the quantization of electric field is in Z-axis

 E_z &= -\frac{\partial\phi}{\partial z} - \frac{1}{c}\frac{\partial A_z}{\partial t} \\
 &= \int \frac{d^3k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_3^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-\vec{k} \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(\vec{k} \cdot \vec{x} - i\omega t)] \\
 \bar{\epsilon}_3^{(\lambda)}(k) &= ik\epsilon_0^{(\lambda)}(k) - \frac{i}{c}\omega\epsilon_3^{(\lambda)}(k)
 \end{aligned} \tag{12}$$

Therefore, the quantization of magnetic field is in Z-axis

$$B_z = \frac{\partial A_y}{\partial x} - \frac{\partial A_x}{\partial y}$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_3^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-k \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(k \cdot \vec{x} - i\omega t)]$$

$$\bar{\epsilon}_3^{(\lambda)}(k) = -ik_2 \epsilon_2^{(\lambda)}(k) + ik_2 \epsilon_1^{(\lambda)}(k) \quad (13)$$

### **3. QUANTIZATION OF ELECTROMAGNETIC FIELD IN RINDLER SPACE-TIME**

Third, in the accelerated frame, the quantization of electromagnetic field is[1]

$$E_{\xi^1} = -\frac{1}{(1 + \frac{a_0 \xi^1}{c^2})} \frac{\partial}{\partial \xi^1} \left\{ (1 + \frac{a_0 \xi^1}{c^2})^2 \phi_\xi \right\} - \frac{1}{(1 + \frac{a_0 \xi^1}{c^2})} \frac{1}{c} \frac{\partial A_{\xi^1}}{\partial \xi^0} = E_x$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_{\xi^1}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-k \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(k \cdot \vec{x} - i\omega t)]$$

$$\bar{\epsilon}_{\xi^1}^{(\lambda)}(k) = \bar{\epsilon}_1^{(\lambda)}(k) = ik_1 \epsilon_0^{(\lambda)}(k) - \frac{i}{c} \omega \epsilon_1^{(\lambda)}(k) \quad (14)$$

Hence, the quantization of magnetic field is in X-axis in the accelerated frame,

$$B_{\xi^1} = \frac{\partial A_{\xi^3}}{\partial \xi^2} - \frac{\partial A_{\xi^2}}{\partial \xi^3} = B_x$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_{\xi^1}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-k \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(k \cdot \vec{x} - i\omega t)]$$

$$\bar{\epsilon}_{\xi^1}^{(\lambda)}(k) = \bar{\epsilon}_1^{(\lambda)}(k) = -ik_2 \epsilon_3^{(\lambda)}(k) + ik_2 \epsilon_2^{(\lambda)}(k) \quad (15)$$

So, the quantization of electric field is in Y-axis in the accelerated frame.

$$= -\left(1 + \frac{a_0 \xi^1}{c^2}\right) \frac{\partial \phi_\xi}{\partial \xi^2} - \frac{1}{\left(1 + \frac{a_0 \xi^1}{c^2}\right)} \frac{1}{c} \frac{\partial A_{\xi^2}}{\partial \xi^0} = E_y \cosh\left(\frac{a_0 \xi^0}{c}\right) - B_z \sinh\left(\frac{a_0 \xi^0}{c}\right)$$

$$= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_{\xi^2}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-k \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(k \cdot \vec{x} - i\omega t)]$$

$$= \cosh\left(\frac{a_0 \xi^0}{c}\right) (ik_2 \epsilon_0^{(\lambda)}(k) - \frac{i}{c} \omega \epsilon_2^{(\lambda)}(k)) - \sinh\left(\frac{a_0 \xi^0}{c}\right) (-ik_2 \epsilon_2^{(\lambda)}(k) + ik_2 \epsilon_1^{(\lambda)}(k)) \quad (16)$$

Therefore, the quantization of magnetic field is in Y-axis in the accelerated frame,

Hence, the quantization of electric field is in Z-axis in the accelerated frame,

 &= -\left(1 + \frac{a_0 \xi^1}{c^2}\right) \frac{\partial \phi_\xi}{\partial \xi^3} - \frac{1}{\left(1 + \frac{a_0 \xi^1}{c^2}\right)} \frac{1}{c} \frac{\partial A_{\xi^3}}{\partial \xi^0} = E_z \cosh\left(\frac{a_0 \xi^0}{c}\right) + B_y \sinh\left(\frac{a_0 \xi^0}{c}\right) \\
 &= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_{\xi^3}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-k \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(k \cdot \vec{x} - i\omega t)] \\
 \bar{\epsilon}_{\xi^3}^{(\lambda)}(k) &= \cosh\left(\frac{a_0 \xi^0}{c}\right) \bar{\epsilon}_3^{(\lambda)}(k) + \sinh\left(\frac{a_0 \xi^0}{c}\right) \bar{\epsilon}_2^{(\lambda)}(k) \\
 &= \cosh\left(\frac{a_0 \xi^0}{c}\right) (ik_3 \epsilon_0^{(\lambda)}(k) - \frac{i}{c} \omega \epsilon_3^{(\lambda)}(k)) + \sinh\left(\frac{a_0 \xi^0}{c}\right) (-ik_3 \epsilon_1^{(\lambda)}(k) + ik_1 \epsilon_3^{(\lambda)}(k))

Therefore, the quantization of magnetic field is in Z-axis in the accelerated frame,

 &= \int \frac{d^3 k}{(2\pi)^3 2k_0} \sum_{\lambda=0}^3 \bar{\epsilon}_{\xi^3}^{(\lambda)}(k) [a^{(\lambda)}(k) \exp(-k \cdot \vec{x} + i\omega t) - a^{(\lambda)+}(k) \exp(k \cdot \vec{x} - i\omega t)] \\
 \bar{\epsilon}_{\xi^3}^{(\lambda)}(k) &= \cosh\left(\frac{a_0 \xi^0}{c}\right) \bar{\epsilon}_3^{(\lambda)}(k) - \sinh\left(\frac{a_0 \xi^0}{c}\right) \bar{\epsilon}_2^{(\lambda)}(k) \\
 &= \cosh\left(\frac{a_0 \xi^0}{c}\right) (-ik_2 \epsilon_2^{(\lambda)}(k) + ik_1 \epsilon_1^{(\lambda)}(k)) - \sinh\left(\frac{a_0 \xi^0}{c}\right) (ik_2 \epsilon_0^{(\lambda)}(k) - \frac{i}{c} \omega \epsilon_2^{(\lambda)}(k))
 \end{aligned} \tag{19}$$
