Azizah Kassim and Nor Halim Hj. Ibrahim has talked about the subject of today's hot topic, the problem of idle land. Azizah Kassim has also deeply identified the problem. He argues that among other government agencies such as FAMA and PPK must also be blamed on the problems faced by farmers. Between the two agencies there is a function of blurring.

The sixth part shows some of the characters who have been honoring the name of Negeri Sembilan. A. Azmi Khalid has not only narrated Dato' Sedia Raja Abdullah bin Dahan, the eighteenth Dato' Undang Rembau's life, but has also fought his struggles to defend the fate of the Malays who were then poor and impoverished. His loud voice was heard at the conferences of the Federal Council. He is also the main critic of his own community. His views are voiced in his many writings in Teacher Magazine. Like Dato 'Abdullah, he is also aware of the problems faced by his people, which are not limited to the Negeri Sembilan Malays alone. Therefore it is not surprising if Dato 'Abdullah and Muhammad Yusof Ahmad are close friends. Adnan Nawang has developed the Za'ba's life as a child who was written by Za'ba himself.
